Structure, Governance and Management

The charity's governing document is a Constitution adopted and signed by six Trustees at a meeting on 26th March 2015. An amendment to introduce a maximum of 11 (eleven) Trustees was approved by at least a 75% majority at the Annual General Meeting held on 19th July 2016.

Confirmation from the Charity Commission that the Trust was recognised as a charity and entered onto their Register of Charities was received on 24th June 2015.

Each Trustee has signed a declaration that they were willing to stand as a Trustee and that they understood the Trust's purposes and rules as set out in the Constitution.

Trustee Robinson, in her capacity as Chair of the Milton Abbas Street Fair Organising Committee, has represented its interests at Trustee meetings.

Three (3) existing Trustees (Stephanie Kogels, Nigel John Hodder and Susan Dawn Woodhouse) will retire at the Annual General Meeting - to be held when Covid-19 lockdown restrictions are fully lifted - in accordance with the Constitution. All are willing to stand for re-appointment.

Objectives and Activities

The objects of the Trust are to advance such charitable purposes (according to the law of England and Wales) as the Trustees see fit from time to time primarily for the benefit of the inhabitants of the Parish of Milton Abbas and its surrounds.

The Milton Abbas Street Fair held on 27th July 2019 was attended by over 6,000 people and provided a mixture of craft, charity and commercial stalls plus a variety of entertainers and food and drink buying opportunities. The weather favoured us this year and, as a result, the Street Fair generated a surplus of approximately £28,500 (plus Gift Aid) for distribution to local beneficiary organisations deemed to have met the public benefit and in accordance with our objects. A small proportion of the surplus has been set aside as a Contingency Fund to ensure reasonable payments to beneficiaries in the outcome of adverse weather conditions impacting on the profitability of future Street Fairs and some to ensure a sound financial base for the 2021 Street Fair.

A robust Safeguarding policy is now firmly in place having been developed over the past year by the Trustees. Operational procedures for the Street Fair were reviewed and subsequently enhanced as part of due diligence.

Achievements and Performance

Awards totalling £20,185 were granted in the past financial year to 19 Beneficiaries (including the Police) from the 2019 Street Fair surplus.

Additionally, following a successful claim of £5,295.90 in Gift Aid and GASDS receipts, a donation of £1,000 was awarded to Teddy 20 - a charity that supports children and young people with Cancer and based in Blandford Forum - and two emergency post Street Fair requests totalling £2,600 were also granted from these additional funds.

Financial Review

The 2019-20 Annual Trust Accounts opened with total balances of £14,388 and closed with £20,048.

The 2019 Street Fair generated an income of c. £53,000 including the Gift Aid monies mentioned above with expenses of £19,450, keeping within the budget of £20,000. An increasing proportion of transactions were completed online, except at the Fair Day itself where mobile signal is limited. Once again there was an increase in 'suppliers' requiring upfront payments, (rather than payment after the Fair had taken place), so the Treasurer recommended that the start-up provision for the 2021 Street Fair be increased to £8,000 to help mitigate these which was agreed by the Trustees.

As agreed at the 2019 AGM a 'Rainy Day Reserve Fund' was instigated and the proposal for agreement by the Membership at this year's AGM of an initial £5,000 allocation was also agreed by the Trustees. As usual the remaining surplus will be retained as a Contingency Fund to provide a reserve to meet potential unforeseen circumstances in the village or any future grant bids between Fairs. Both these elements will form part of the Trust's new Reserves Policy that will be developed during the upcoming financial year.
